**POSITIVE PROFIT ALERT**

This announcement is made by OOH Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2)(a) of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform shareholders of the Company (the “**Shareholders**”) and potential investors that based on the latest review of the unaudited management accounts (the “**Latest Management Accounts**”) of the Group for the nine months period ended 31 December 2021 (“**9M2022**”), the Group is expected to record a net profit of approximately HK\$2.9 million for 9M2022 as compared to a net loss of approximately HK\$3.2 million for the nine months period ended 31 December 2020 (“**9M2021**”).

The expected turnaround from a net loss for 9M2021 to a net profit for 9M2022 was mainly attributable to:

1. the increase of revenue generated from minibus advertising during 9M2022 as compared to that of 9M2021 due to the increase of revenue generated from both direct and agency clients, which the Directors believed was attributable to the improved market sentiments;
2. the increase of revenue generated from taxi advertising during 9M2022 as compared to that of 9M2021 mainly due to the increase of the revenue generated by direct clients, which the Directors believed was attributable to the improved market sentiments, and governmental tender projects; and
3. the increase in gross profit margin of minibus advertising mainly due to the concessions on licence fee granted by the minibus operators by virtue of the outbreak of COVID-19.

The information contained in this announcement is only based on a preliminary assessment by the Board with reference to the Latest Management Accounts and the information currently available to the Company. Such information has not been reviewed or confirmed by the auditor or the audit committee of the Company. Further details of the Group's performance will be disclosed in the third quarterly results announcement of the Company for 9M2022, which is expected to be published on 7 February 2022.
