PROFIT WARNING

This announcement is made by OOH Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2)(a) of the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform shareholders of the Company (“**Shareholders**”) and potential investors that based on the latest review of the unaudited management accounts (the “**Latest Management Accounts**”) of the Group for the three months period ended 30 June 2022 (“**3M2023**”), the Group is expected to record a net loss of approximately HK\$2.1 million for 3M2023 as compared to a net loss of approximately HK\$1.1 million for the three months period ended 30 June 2021 (“**3M2022**”).

The expected increase in loss was mainly attributable to a combination of (i) the decrease of overall revenue of the Group by approximately 13.6% from approximately HK\$11.8 million for 3M2022 to approximately HK\$10.2 million for 3M2023; and (ii) the decrease of overall gross profit margin of the Group from approximately 37.8% for 3M2022 to approximately 29.4% for 3M2023. Such decreases were mainly contributed by the outbreak of the fifth wave of COVID-19 which led to the poor market sentiment.

The information contained in this announcement is only based on a preliminary assessment by the Board with reference to the Latest Management Accounts and the information currently available to the Company. Such information has not been reviewed or confirmed by the auditor or the audit committee of the Company. Further details of the Group’s performance will be disclosed in the first quarterly results announcement of the Company for 3M2023, which is expected to be published on 5 August 2022.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
